Monday, May 18, 2020 Village Board Regular Meeting Agenda

PUBLIC NOTICE - In accordance with the applicable statutes of the state of Illinois and Ordinances of the Village of Wheeling, notice is thereby given that the REGULAR MEETING OF THE VILLAGE BOARD will be held in the Board Room, Wheeling Village Hall, 2 Community Boulevard, Wheeling, Illinois on May 18, 2020 at 6:30 p.m. Due to the ongoing public health emergency, and based on the authority provided by Executive Order 2020-07 issued by Governor Pritzker on March 16, 2020, and Executive Order 2020-10 issued by Governor Pritzker on March 20, 2020, as extended by Executive Order 2020-018 issued on April 1, 2020 limiting public gatherings and suspending the Open Meetings Act physical presence requirement, the majority of the Village Board will be attending the meeting by video teleconference. The Village President and selected staff members will be present at the Village Hall, which will be open to the public for the meeting. Members of the public can view the meeting, which will be televised on channels 17 and 99 and online at www.wheelingil.gov.

Voicemail messages may not exceed five (5) minutes. Voicemails left before 12:00 p.m. on the date of the meeting for the purpose of providing comment to the Village Board will be played at the meeting during Citizen Comments.
- 2) Members of the public may also appear at the Village Hall on the date of the meeting in order to sign in on a timely basis and to make their public comment. No more than ten (10) individuals will be allowed to be present in the Village Board room at any time. Members of the public who sign in to speak prior to the beginning of the meeting will be asked to wait in the room outside the Board Room where the meeting can be watched by video monitor and social distancing requirements can be observed. Members of the public who sign up to speak in advance of the meeting will be called in to the Board Room individually in order to make their public comments.
