Wheeling Signs Intergovernmental Agreement with MWRDGC and Park District

A first-of-its-kind agreement was recently signed by the Village of Wheeling, the Wheeling Park District and the Metropolitan Water Reclamation District (MWRD) of Greater Chicago. This intergovernmental agreement will help initiate the Levee 37 project which will create compensatory water storage and flood control for homes and businesses along the Des Plaines River without giving up recreational space for the Heritage Park Master Plan. Land currently owned by the Park District and the Village of Wheeling will be given to MWRD for compensatory storage, and in exchange for the use of the land, MWRD has agreed to develop portions of Heritage Park in keeping with the Master Plan and to provide compensatory water storage space for the Village. Both Levee 37 and the renovated Heritage Park will be celebrated assets to our Village. We look forward with great anticipation to the future Heritage Park as well as long-awaited flood control for our residents along the river. Construction for these projects is slated to begin in 2012.

New Police Chief and Deputy Police Chief Appointed

At the Board meeting of April 12th, Village Clerk Elaine Simpson swore in new Police Chief Bill Benson and new Deputy Police Chief John Teevans. As a Board we are extremely pleased to be able to promote two hard-working, dedicated employees from within our own ranks. Each of these men has dedicated over 20 years in the Wheeling Police Department to serving the Village's residents and it seems only right that they now lead all of our police officers in serving and protecting our community. We congratulate them on their new roles and have full confidence in their abilities.

Police Station Renovation on Schedule

The Police Station renovation is now approximately 50% complete. Completion of the center of the building including carpeting, final paint, and furniture is expected to be in mid-May. Completion of the west side of the building, which now only requires carpeting and final paint, is expected in to be in early June. Police personnel have adjusted well to continuous construction over the past eight months, the project is progressing smoothly, and expenditures are within budget. We are all looking forward to the completion of this project!

New Fire Station Nearly Open for Business

The new fire station located at 499 S. Milwaukee Avenue is nearing completion and is expected to go into operation at the end of June. Once open, the new fire station will house several fire suppression and emergency medical units staffed by up to eleven emergency responders per day, as well as the Fire Department's administrative offices. The approximately 20,000 square foot building was originally projected to cost \$7 million. Due to a highly competitive construction market combined with value engineering in both design and construction methods, the completed project will cost approximately \$5.9 million; approximately 20% under its original budget. A formal dedication and open house is scheduled for Saturday, October 2, 2010—the beginning of National Fire Prevention Week—and all residents are welcome to attend. Economic Development Promotion through Issuance of Industrial Revenue Bonds

Each calendar year, the Village of Wheeling receives private activity bonding authority from the State of Illinois. The purpose of this bonding authority is to encourage economic development within Wheeling by enabling manufacturing companies to finance, through the issuance of tax-exempt Industrial Revenue Bonds (IRBs), the acquisition of fixed assets such as land, buildings and equipment. In some cases, bond proceeds may also be used for new construction or renovation. Qualified IRB projects include facilities that are primarily used to manufacture or process tangible products.

Final determination of project eligibility is subject to a legal opinion from a recognized municipal bond attorney. If you have a project you believe may qualify for private activity bond financing and would like more information about this program, please contact the Village's Director of Finance, Michael Mondschain, at 847.499.9020. This is a great tool for our Industrial businesses.

Rain Barrels

A rain barrel can help you save water, prevent flooding and grow a garden.

Rain barrels are containers that collect and store rainwater from rooftops via downspouts. Because it does not contain minerals, chlorine, fluoride or other chemicals, the stored rainwater in barrels provides a supply of water that is ideal for gardens, potted plants/flowers, lawns, and even bicycle and car washing. Rain barrels reduce storm water pollution and conserve water.

As part of their ongoing water conservation program, the Metropolitan Water Reclamation District (MWRD) has rain barrels for sale for \$50.00 each. There is a limit of two (2) barrels per household. MWRD only accepts orders that are placed on their

website and purchased with a credit card—no cash or check sales at pick-up locations. There are also no returns or exchanges. Rain barrels are 55 gallons with a diameter of 21 inches and a height of 34 inches.

Residents are required to print their receipt when purchasing their rain barrel online. Please bring your receipt and a vehicle that will accommodate the barrel. Rain barrel distribution takes place during the first Saturday, Tuesday or Thursday of each month only at:

To order a rain barrel or for more information, please go to www.mwrdd.org and follow the link for rain barrels. Please keep barrels hidden or camouflaged (behind bushes, etc.) if possible and keep them along the side or rear of lots.

Property Maintenance Time

Community Development Property Maintenance Staff will be out in force this summer ensuring properties in our community are observing the following property maintenance guidelines:

- Grass/Weeds maintained (Maximum height for grass is 8") *12.04.010.*
- Bushes/Trees properly maintained including removal of dead, and trimming of overgrown and improperly maintained *12.20.025*
- Exterior free of cracking and peeling paint
- Fences, sheds and other accessory structures in good repair
- Garbage cans stowed in the garage or adjacent to the house in a side or rear yard between pick-up days. *5.32.040 (e).*

You take pride in your home and keep it ship-shape inside and out, but you notice a home or two in the neighborhood is having trouble doing the same. What do you do to keep your neighborhood looking neat? If you notice ill-kept properties in your neighborhood, please contact Community Development at 847.459.2620, so that our staff can investigate the status of the property and take steps to re-establish maintenance at the site.

Replacement Program Deferred

The shovel-ready 2010 Water Main and Storm and Sanitary Sewer Replacement Program has been deferred from this year's Capital Improvement Plan Project schedule due to insufficient funding for the entire scope of the project. Full funding for this project is anticipated to be available to complete these improvements in 2011. New LED Streetlights Coming

New energy efficient Light Emitting Diode (LED) fixtures will be replacing existing metal halide streetlight fixtures in the Hollywood Ridge, Poplar Grove, Dunhurst, Old Town and Meadowbrook residential neighborhoods. Benefits of LED fixtures include durability, long life expectancy, energy efficiency and ultimately cost savings. This program is primarily funded through a federal grant. Installations by the Village of Wheeling Public Works Street Division staff will begin soon. On March 17th the Public Works Utility Division won 4th place in the Annual Illinois Section American Water Works Association Water Tapping Competition in Springfield, Illinois. In this state competition, various teams contend to install a ¾ inch tap for the quickest time possible. The Village team began participating in this aggressive competition in 2007. The first year the Village won 4th place; in 2008 the Village won 2nd place and in 2009, the Village won 3rd place. Way to go guys!!

Floods are no Myth; Be Prepared for the Unexpected

Discounts on homeowner flood insurance premiums are just one of many benefits residents enjoy as a result of Wheeling's proactive approach to flood hazard damage reduction. A 28-year member of the National Flood Insurance Program (NFIP), Wheeling has joined a national effort to minimize property damage in cases of flooding and provide affordable flood insurance to all homeowners, whether or not they are located in or near a flood plain. As part of its NFIP commitment, the Village provides a range of public information on flooding potential, prevention, safety, and other issues. LOCAL FLOOD HAZARD POTENTIAL

The Village's proximity to waterways such as the Des Plaines River, Buffalo Creek and McDonald Creek tributaries adds scenic charm to historic Wheeling. Unfortunately, those same waterways raise the hazard of flooding during heavy rains. Standard homeowner's insurance does not cover flooding. Through the 1960s, private insurance company rates on flood insurance were prohibitively high. These excessively high prices made it almost impossible to carry flood insurance. The NFIP, formed in 1968, is designed to subsidize the cost of flood insurance to member communities, qualify them to receive disaster relief and establish minimum national standards to reduce flood losses.

HIGH CRS RATING

One of eight inaugural NFIP communities in Illinois, Wheeling designed programs to exceed minimum standards and optimize benefits to Village residents. In 1992, the NFIP implemented the Community Rating System (CRS) to reward efforts of communities that go above and beyond the basic requirements. Effective May 1, 2007, our rating was upgraded to Class 7, which provides a 15 percent discount on flood insurance policies for properties located within the special flood hazard area. Policies issued for properties outside the special flood hazard area continue to receive a 5 percent discount. The Village of Wheeling continues to be proactive in preventative initiatives, including:

Stream maintenance – The Village regularly inspects waterways to ensure they are clear of debris and potential obstructions. The Village recently completed a streambank stabilization and erosion control project along a portion of Buffalo Creek west of Route 83.

Regulating new construction – New buildings in the flood zone must meet requirements for elevation and flood-proofing. Village planners ensure that the new developments don't raise flood risk for neighbors in the community.

Keeping residents informed of flood risk and how to minimize impact – Flooding is not a topic the Village wants to highlight, but our residents must be aware of the potential for flooding. Tools such as this newsletter enable us to keep residents informed in the event of flooding.

DEVELOPMENT REGULATED

Development of any type within special flood hazard areas is strictly regulated. In order to construct a building or addition, perform any grading or fill any other type of construction in these areas, an individual must obtain a special "floodplain development permit." This permit is issued in conjunction with other construction permits to assure that the new construction will not be susceptible to flood damage or cause increased flood damage potential to neighboring properties. Floodplain development regulations can be found on the Village website at www.wheelingil.gov in Title 22 of the Municipal Code which can be found under the Reference tab on the Home Page or by contacting the Community Development Department at 847.459.2620.

With flooding a possibility, especially during the summer storm season, preparation is the best defense. Safeguarding people, protecting buildings and purchasing flood insurance are keys to defending against floods.

PROTECT YOUR PROPERTY

To flood-proof a structure, start by elevating or relocating electrical panel boxes, furnaces, water heaters and washer/dryers to areas least likely to be flooded. Install basement floor drains and interior and exterior backwater valves. Consider erecting interior flood walls around utilities. Move essential items and furniture to the upper floors of your home if flooding is likely. Keep materials such as sandbags, plywood, plastic sheeting and lumber handy for emergency waterproofing. More flood protection information is available from FEMA through a link on the Home Page of the Village of Wheeling website at www.wheelingil.gov. Information is also available for review at the Indian Trails Public Library.

PERSONAL SAFETY

During periods of high water, stay out of the basement where breaker boxes and electrical wiring present the risk of shock. If you know high water is imminent, shut off the electricity, gas and water. Keep your family together and make sure everyone has identification. Move everyone, including pets, to high ground. Rescue crews cannot reach you once the water becomes two feet deep. Don't drive across flooded roads where your vehicle could stall. Flowing water above your knees can generate dangerous currents. Avoid walking through it.

VILLAGE MONITORS RISING WATER LEVELS

When heavy rains strike, the Village monitors rising water levels with gauges strategically located throughout the Village. Comparing data with historic records, the Village can predict areas of potential flooding. In the event of a flooding situation, Village staff is mobilized to notify people in affected areas. In some situations, notification may be made by phone. Road closure information is available from radio stations.

Got Mail?

Did you know... the Village of Wheeling has standards for residential mail boxes which have been approved by the U.S. Postal Service? All mailbox supports and any variation to the standard must be approved by the Village of Wheeling prior to installation. Electronics Recycling

In September 2009 Illinois adopted an electronics recycling law which will ban certain electronic items, mainly computers, monitors, televisions and printers, from Illinois landfills beginning in January 2012. To assist residents with environmentally safe recycling, the Solid Waste Agency of Northern Cook County (SWANCC) is currently offering drop-off locations to SWANCC residents. (SWANCC services Wheeling residents).
