Ms. Knysz referred to the lighting changes that were mentioned in the discussion from the previous docket. She noted Staff had not received anything about light fixtures so a condition may need to be added. If they are changing the light fixtures, it needs to be reviewed by Staff.

Commissioner Sprague asked if they were planning to paint the brick on the building gray. He noticed the mortar and brick needed some tuckpointing. façade of the building around the bay doors will be painted gray. Ms. Knysz noted it was difficult to tell the color/material between the bay doors. Chairman Johnson mentioned the Commission was typically not in favor of painting brick. Ms. Knysz asked for confirmation if the areas shown as gray was definitely brick. She thought the area on the west side of the front also looked like brick. Commissioner Yedinak looked at Google Earth and confirmed the entire west side of the front was brick and in between the bays looked like it was also brick and the entire post on the last bay door was brick. After discussion, the petitioner agreed not to paint the brick.
